CHAIR & PRESIDENT/CEO REPORT

Vermont Federal Credit Union continues to play an integral part in our members' lives and the communities we serve. Our purpose as an organization is to help Vermonters prosper, no matter where they may be on life's journey. Our Credit Union is all about people helping people, and more specifically, helping Vermonters by offering them the best financial products and solutions and supporting the communities where we live and work. Vermont Federal Credit Union is an inclusive organization run by Vermonters, for ALL Vermonters. The growth, accomplishments, and accolades we received in 2023 are a testament to the fact that our Credit Union continues to make a real difference in the lives of our members.

2023 was another year of continued growth and evolution for Vermont Federal Credit Union. At the end of the year, our Credit Union was comprised of over 53,000 members, with assets over \$932 million. Our consumer loans increased by \$78 million, which represents an annualized growth rate of 12%. We were able to help 190 members finance or refinance their homes and we provided car loans to more than 2,900 members. Our Business Banking team provided over 230 commercial loans to help local businesses start or expand their operations. We ended the year with over 26,000 active Reward Checking accounts. We returned over \$9.5 million in dividends and more than \$270,000 in ATM fees. Despite a challenging rate environment in 2023, our Credit Union had a net income of \$7.7 million, representing a return on assets of 0.83%, and our membership grew at a rate of 6.88%.

In our relentless pursuit of excellence, we continued to evaluate our products and services to provide our members with an unparalleled experience. In 2023, we introduced Cannabis Banking and have welcomed over 300 new Cannabis Banking members to our Credit Union with approximately \$12.6 million in deposits. We introduced a new Vehicle Search Tool, which allows our members to shop for a variety of vehicles directly on our website. We introduced a new Solar Loan to help members reduce their energy bills and carbon footprint. Our team worked to upgrade our consumer loan origination system to provide our members with a more efficient and seamless member experience. We evaluated our Contact Center experience and implemented numerous new features and best practices to enhance our member support. Additionally, our retail teams received extra coaching and training to improve the branch experience. We also conducted a thorough analysis of our Online Banking platform and have introduced a new

We continuously look for areas and communities where we believe we can make a significant contribution, and we are extremely proud to announce the opening of our newest branch, located at 315 North Main Street in the heart of Barre, Vermont. This new facility improves the convenience and accessibility of our branches, and underscores our commitment to supporting the residents and businesses within Barre and the surrounding communities. another example of our unwavering dedication to delivering top-notch financial services to communities throughout all of Vermont.

As a local Credit Union, we are proud to serve and support the communities that we call home. Community engagement, outreach, volunteerism, and charitable giving are a cornerstone of our Credit Union. In 2023, our employees devoted over 2,000 hours supporting local events and causes throughout Vermont. As an organization, we sponsored and supported 85 local events and contributed over \$220,000 to local organizations. We donated financial support to 40 charitable organizations across the state, including Spectrum Youth and Family Services, The Vermont Foodbank, Capstone Community Action, Help Overcome Poverty's Effects (HOPE), Pride Center of Vermont, LUND, and many others. We also partnered with local news outlets such as NBC5, FOX44, and WCAX to collect food, school supplies, and winter coats for those in need. In addition, we provided \$30,000 in scholarships to deserving students from our membership, and through partnerships with The National

Guard Association of Vermont, Burlington Cars, Boys and Girls Club of Burlington, and Spectrum Youth and Family Services.

Our commitment to Vermont and our unwavering support of our members has not gone unnoticed in the communities we serve. We were awarded the Forbes Best-in-State Credit Union in 2023, and we are the only Credit Union in Vermont to have received this award 5 times in the past 6 years. Our Credit Union was given the Best of Business award for Franklin/Grand Isle/ Addison/Windham/Windsor counties by Vermont Business Magazine. We were also awarded the Raddon 2023 Crystal Performance Award, which highlighted 21 Credit Unions across the United States. Vermont Federal Credit Union was among the top 5% of Credit Unions whose results and metrics were analyzed by Raddon. Vermont Federal Credit Union was also recognized as a Top Performer in 2023 by the Vermont Housing Finance Agency (VHFA) and was awarded the 2023 Best of the Best Award by MemberXP, which is an organization that evaluates Credit Unions across the country based on member feedback. Our Credit Union ranks among the

top in the country and was ranked #1 in the state of Vermont by the independent research group Callahan & Associates for the amount of value that we give back to our members each year in the form of higher deposit rates, lower loan rates, and fewer service fees. And finally, we received a 2023 Governor's Excellence in Worksite Wellness, which is a reflection of our dedication to our team.

We are extremely proud of all that we accomplished in 2023. Our members and their needs are at the forefront of all that we do, and we can feel good about how we have helped so many Vermonters prosper. Our team demonstrated an unwavering dedication and commitment to our members and our community, and we are extremely grateful for their hard work and dedication.

We are Vermonters, serving fellow Vermonters. We are proud of what we accomplished in 2023, and we are committed to your continued success in 2024. On behalf of our entire team, volunteers, and the Board of Directors, we thank you for your membership and we look forward to serving your needs now and in the future.

FINANCIAL WELLBEING

We expanded our Financial Wellbeing programs by partnering with Greenpath Financial Wellness, which assists our members with finding their path to financial health. They offer free counseling and coaching sessions with certified financial wellness experts. We also introduced a financial checkup via SavvyMoney, which offers credit score monitoring, a financial health score, and budget analysis.

This program offers an additional \$15,000 fully forgivable grant, which has provided crucial support for covering closing costs or contributing towards down payments for qualified applicants.

SPECTRUM YOUTH AND FAMILY SERVICES


